- 1. SWEEPSTAKES PERIOD:** The You Give, We Gift Sweepstakes (the “Sweepstakes”) will begin at 12:00 a.m. P.T. on Tuesday, November 2, 2021 and end at 11:59 p.m. P.T. on Tuesday, November 16, 2021 (“Sweepstakes Period”) during the Sweepstakes Period.
